Pelican Lake Agricultural Society Fair Horse Show Waiver and Release

THIS DOCUMENT WILL AFFECT YOUR LEGAL RIGHTS AND LIABILITIES. PLEASE READ CAREFULLY.

I the undersigned _____ (please print) understand that it is my responsibility and that I accept all liability for the horse activity of the Pelican Lake Agricultural Society Fair (PLAS) that I undertake on behalf of myself, a horse(s) or a junior rider.

I acknowledge that the sport of riding, including in hand, schooling, showing, competing in gymkhana events is a high-risk sport and that I am taking part at my own risk and in full knowledge of the hazards and potential hazards which are inherent in this sport. I further acknowledge the inherent risk in riding and working around my own, and other horses and people, equipment and machinery. The risks include but are not limited to bodily injury to horse, handler and rider which can result from normal use, competition or schooling. It is recognized no helmet or protective equipment can fully protect the rider or horse from all injuries that may be suffered arising from the acknowledged risks.

In consideration of participation in this horse activity, PLAS Horse Show, June 14, 2025 as an adult rider or as an owner, handler or as the person otherwise responsible for the horse, as the case may be, and if applicable, on behalf of _____

a junior rider for whom I am responsible, I hereby assume all risk and I hereby release and absolve the organizing committee, PLAS and their officials, volunteers, officers, directors, agents, representatives and employees, independent contractors and the owners and occupiers of all lands upon which the riding/horse handling activity is held including but not limited to the lands of the PLAS from all responsibility, liability or claims of any nature and kind which I may have arising from my participation or involvement in these activities or from my horse(s) participation or involvement at this event including but not limited to bodily injury or death to myself or my horse(s) and damage to property arising from any cause whatever, including the negligence of one or more of the individuals and organizations referred to herein.

I hereby hold harmless the PLAS for any and all injuries I may sustain or that I or any horse or any junior rider for whom I am responsible may sustain or cause to other horses or people while attending PLAS Fair horse show or while I or my horse(s) or any junior rider for which I am responsible are present on PLAS property.

Myself or _____, a junior rider for whom I am responsible, participates in the PLAS Fair horse show with full knowledge that wearing an approved protective helmet is highly recommended but failure to wear one is strictly my decision and responsibility.
